As initially disclosed in the October 14, 2025, update, the Tax-Exempt Private Credit Fund (TSIFX) is currently under contract to divest the entirety of its remaining portfolio holdings after receiving multiple indications of interest and multiple bids.

Following a comprehensive review of all bids received, the highest offer available was approved, which reflects prevailing market conditions as well as the current financial position of the portfolio holdings and the Fund.

The sale of the assets is still expected to close prior to November 30, with a final liquidating distribution to shareholders shortly thereafter.
